Dear Senator Reid:

On behalf of the undersigned members of the Coalition for 21<sup>st</sup> Century Patent Reform, which represents many of the nation's leading companies in a wide variety of industries and technologies, we urge you to delay floor action on S. 1145, the Patent Reform Act of 2007, while industry stakeholders continue to work through the myriad of issues that were not adequately resolved during last week's Committee markup.

The bill as reported contains provisions, including a significant change in the manner in which patent infringement damages are calculated, that would deter innovation by weakening the U.S. patent system. It also undermines the ability of our companies to compete in an increasingly global economy. Because of the bill's critical importance to our country's continued economic leadership in the world, we should take the time necessary to ensure that all of the public policy issues are discussed and worked through in a careful and deliberative fashion before asking the entire Senate to vote on the patent legislation.

Our Coalition welcomes efforts to improve the existing patent system and is committed to working with Congress and other stakeholders to strengthen the bill as reported. We ask you to provide us with the time necessary to accomplish that task by agreeing not to move this bill to the floor in its current form.
